S.O.----- (E)----- In exercise of the powers conferred by sub-sections (1) and (2) of section 16 read with section 17 and sub-section (3) of section 25 of the Bureau of Indian Standards Act, 2016 (11 of 2016), (hereinafter referred to as the said Act), the Central Government, after consultation with the Bureau of Indian Standards, being of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following Order, namely:-

1. Short title and commencement and application. – (1) This order may be called the Dyed knitted or crochet fabric made from synthetic fibres (Quality Control) Order, 2024.

(2) It shall come into force with effect from the ----- day of -----, 2024.

(3) It shall apply to goods or articles specified in column (1) of the Schedule annexed to this Order and shall not apply to such goods or articles meant for export, which conform to the specification required by the Foreign Buyer.

2. Conformity to standards and compulsory use of Standard Mark. - Goods or articles specified in column (1) of the said Schedule shall conform to the corresponding Indian Standard given in column (2) of the said Schedule and shall bear the Standard Mark under a licence from the Bureau of Indian Standards as per Scheme-I of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018.

3. Conformity Assessment, Certification and enforcement authority - The Bureau of Indian Standards shall be the certifying and enforcing authority in respect of the goods or articles specified in column (1) of the said Schedule.

4. Penalty for contravention. - Any person who contravenes the provisions of this order shall be punishable under the provisions of the said Act.
